My Name is Sal Anicito. I am 65 years of age and served in Law Enforcement from 1986 to 2016. I served with the City of Fort PierceFlorida from 1986 – 1998 and with the St. Lucie County Sheriff's Office from 1998 to 2016 when I retired. I am currently the Treasurer for Blue Knights Chapter X in Port St. Lucie Florida. After being hired with the Police Department the very first training school I attended was Radar Operator and became Radar Certified in 1986.

In 1988 I was assigned to the Traffic Division to serve as a Motorcycle Unit. I served as a Traffic Instructor at the Police Academy at Indian River State College teaching Traffic Stops and Enforcement Procedures. I attended and successfully completed Basic Police Motorcycle School in Orlando Florida. As a Traffic Motor Unit in a city of seventy plus thousand people I spent numerous hours on traffic enforcement assignments which included the running of radar in problem areas of our city, School Zone Enforcement, crash investigations, doing Special Events (such as parades) and escorting local funerals. I attended and successfully completed Police Motorcycle Instructor School held at The Institute of Police Technology and Management (IPTM) in Jacksonville Fl. becoming an Instructor in 1990 certifying Police Officers and Deputy Sheriffs to safely and effectively operate Police Motorcycles.

During my tenure as a Motor Officer I attended and successfully completed Traffic Homicide School and Advanced Traffic Homicide School (also at IPTM) and for a period of time I was the only Traffic Homicide Investigator of my Agency investigating numerous fatality crashes and testifying in numerous Court proceedings. I became a Traffic Crash Investigations Instructor for the Basic Police Academy at Indian River State College and remained an Instructor in this Discipline until my retirement in 2016. I competed in the Police Motorcycle Skills Championship held each year at the Daytona Beach International Speedway, competing on a low speed obstacle course with Motor Officers from throughout the country in which I placed 15th place out of 105 Motor Officers.

Currently I ride a 2006 Harley Davidson Ultra Classic with 57,000 miles which I bought new. I am a conscientious motorcycle rider and still keep up the skills I was taught as a result of my training for safe riding. I am proud of my 30 year Law Enforcement career and I am proud to be a Blue Knight. I am very appreciative and Thankful for being selected to serve as Safety Officer for the Southern Region Conference.
